In reflecting upon 2023 there were three words that kept coming to my mind in the approach of the agency, its Board, its senior management, and its customers. Those three words embody a spirit that was never more evident than the 365 days that comprised 2023. Those three words were "No Matter What". It would have been hard to imagine 2023 unfolding as it did.



Agency office locations in Meriden and its Early Childhood Center in Waterbury faced flooding within a week of each other in the summer. Yet the staff in those locations continued to support families and children without ever closing.

The Family Empowerment Division faced the tragic loss of their leader Dr. James Perry yet continued to support a record number of customers needing housing assistance, health coverage, state benefit assistance, and employment assistance. Record numbers of seniors were engaged to join the corps membership of senior volunteer programs.

The Energy Assistance program provided assistance to an unprecedented number of customers even though the program started a month later than normal. They also adjusted to a new online portal and an increasing number of fuel vendors partnering for customer deliveries.

The Senior Nutrition program needed to adjust to decreased funding availability with meal delivery being reduced to 4 days/week. In spite of this change the program continued to provide compassionate engagement to homebound seniors.

In the midst of one of the worst housing crises the State has seen the staff of New Beginnings Emergency Shelter, Meriden/Middletown/Wallingford Coordinated Access Networks, and Rapid Re-housing continued to seek and provide safe housing options for homeless individuals and families.

The staff in both Meriden and Torrington locations endured an office move to new spaces which will afford a deeper engagement with customers and community partners.

The Board of Directors experienced the retirement of 2 long standing agency champions who understood and lived out the agency's mission.

Any number of these items could have had drastic impacts on the day to day function of the agency yet the staff, board, and customers demonstrated a "No Matter What" approach to ensuring that needs were met and the agency continued to adapt to become even more dynamic. It is in the face of adversity that the foundation of an organization is truly revealed and that was never more evident than in 2023.

In closing I look with eager anticipation to what the 366 days will bring in 2024 but I am confident that all facets of the agency will endure with care and compassion "No Matter What".

Whether it's examples, such as Early Childhood Education, Community Health and wellbeing, Senior Volunteer Services or Meals on Wheels, New Opportunities' offerings have always reflected the diversity of the clients and communities serve. Our agency's growing client-base is the common-currency that has driven us to establish accelerated standards of efficacy and efficiency that provide individualized services that build and sustain self-sufficient lives.




Race and Ethnicity


Paying Homage...








Quincy has been a Meal on Wheels customer since 2019. Due to his poor mobility and medical conditions he is unable to physically shop and cook for himself. Meals on Wheels provides him with comfort, safety, and security knowing he has a well-balanced meal to eat daily.

Quincy also participates in the Animeals program that delivers cat litter and food for his trusted companion, Masie, once a month. At a recent pet wellness clinic hosted by NOI's Senior Nutrition Services department in collaboration with the CT Humane Society, Quincy and Masie were provided transportation to the clinic where she received a wellness exam, vacccinations and grooming.

New offices!

New Opportunities of Greater Meriden has a new home! The office is now co-located with their community partner, Meriden Housing Authority. The Meriden team to continue providing high quality services in a spacious, welcoming environment where the focus continues to be on CT DSS application Assistance for SNAP, medical, case management and mediation with landlords regarding rental assistance to prevent eviction Along with this relocation, Operation Pantry, a partnership with CT Food Share, has expanded space to organize perishable and non-perishable food items for easy access to area residents.

The new space has created opportunities for Hartford Health Care to sponsor monthly health clinics along with their mobile health van. Monthly informational workshops on job seeking strategies, resume building and budgeting allow clients to meet in small groups to gain skills, ask questions and share experiences. The new physical space open doors for opportunities to engage area residents.



New Opportunities of Greater Torrington's

move to a new office that is co-located with the Department of Social Services (DSS) offices has allowed a strategic partnership that has significantly expedited the application process for benefits, particularly Supplemental Nutrition Assistance Program (SNAP) applications, health insurance enrollments, and cash assistance. The seamless coordination between New Opportunities and DSS has reduced barriers and has provided clients with personalized assistance, ultimately improving their overall experience.

Addditional collaborations have been established that benefit the clients in this community. A stronger relationship with Hartford HealthCare has promoted more accessiblity to healthcare for those who lack medical insurance and face significant barriers to healthcare access.



Jackie is a dedicated healthcare worker at Danbury Hospital and a single mother. She recently made a significant investment in her family's future by purchasing a condo in Waterbury. However, this purchase exhausted all her savings, leaving her struggling to keep up with expenses while juggling a demanding job and raising her children. She had been saving for essential appliances like a fridge and a dishwasher, but her financial situation made it impossible to afford these items.

In August 2023, Jackie decided to seek assistance and applied to the First Time Home Buyer program for help. Her application was swiftly approved in September, providing her with the funds needed to purchase the much-needed appliances for her home. She was overjoyed and relieved to receive this support, which significantly improved her family's quality of life.


